

# **HOME CYCLE FAQs**

## Why does Monterey Peninsula Foundation have three cycles?

The Foundation established this timeline to better incorporate the golf tournaments we host (AT&T Pebble Beach Pro-Am and PURE Insurance Championship, Impacting the First Tee) into the grantmaking schedule.

What are the grant application and reporting deadlines?

Monterey Peninsula Foundation typically has three grant cycles each year. All organizations must choose a Home Cycle before applying and adhere to respective dates for applications and reports.

IMPORTANT: Cycles have been updated, please note the following dates:

#### • Summer Cycle 2022

- April 1 application deadline for July Review
- Grant timeframe is July 1-Feb 28 (8 months)
- Grant Report due March 1, 2023

#### • Fall Cycle 2022

- o July 15 application deadline for October Review
- Grant timeframe is Oct 1-May 31 (8 months)
- o Grant Report due June 1, 2023
- Winter Cycle 2022\*
  - o December 1 application deadline for April Review
  - o Grant timeframe is April 1-Nov 30 (8 months)
  - Grant Report due December 1, 2023

#### • Fall Cycle 2023

- July 1 application deadline for October Review
- o Grant timeframe is Oct 1-May 31 (8 months)
- Grant Report due June 1, 2024

## • Winter Cycle 2023\*

- o December 1 application deadline for April Review
- o Grant timeframe is April 1-Nov 30 (8 months)
- o Grant Report due December 1, 2024
- Summer Cycle 2024
  - o March 1 application deadline for June Review
  - Grant timeframe is June 1-Jan 31 (8 months)
  - Grant Report due February 1, 2025

\*K-12 schools (public, private and charter) and school districts should plan to apply in the Winter Cycle.

**NOTE:** You must strictly adhere to your application and report deadlines. Submitting your application or report late may result in the denial of your new application and ineligibility to reapply for one year.

# Will we need to stay within a given cycle for our future applications?

Yes. We ask applicants and grantees to select the best timeframe for their needs. Once a Home Cycle is selected, we require grantees and applicants to remain within that cycle for all future applications. By making the selection of a Home Cycle that matches fiscal needs, applicants and grantees are more likely to have required documents ready to share with funders.

#### If our situation changes, can we discuss the need to change cycles?

We are happy to discuss specific situations. We ask that agencies take the time to think through their selection of a Home Cycle to ensure it is a good fit. Pertinent questions for grantees:

• When is the agency's fiscal year?

- What financial reports are required? When will they be produced? Are the appropriate fiscal year budgets drafted by the application deadline?
- Is there adequate funding to accommodate a timing change? Does cashflow impact the home cycle selection?
- What is the fiscal impact of when funds are received and when they are spent? Can we spend the grant funds within the required reporting period?

Is there anything else changing this year that we should be aware of?



While there are many things to consider, fiscal year timing is an important one. The closer to the start of your fiscal year, the more likely you are to have budgets and materials appropriate to submission.
